Invitation for Bids for the Construction of 15 Bed Hospital at AadarshaKotwal Rural Municipality

1. The Government of Nepal [GoN] *has allocated funds towards the cost of the Construction of 15 Bed Hospital at AadarshaKotwal Rural Municipality , Bara* and intends to apply part of the funds to cover eligible payments under the Contract *for Construction of 15 Bed Hospital at AadarshaKotwal Rural Municipality, Bara (Contract No. AKRM/NCB/01/2078-079)*. Bidding is open to all eligible as per Section V of bidding document.
2. *AadarshaKotwal Rural Municipality, Bara* invites electronic bids from eligible bidders for the *Construction of 15 Bed Hospital* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 8,25,00,000.00**.
 - Minimum Work experience of similar size and nature: 1(One), with the amount of **NRs.(13,20,00,000.00)**.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of *AadarshaKotwal Rural Municipality, Madhesh Province, Bara* (www.aadarshakotwalmun.gov.np) or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 5. If hard copy is allowed then a complete set of Bidding Documents may be purchased from the office *AadarshaKotwal Rural Municipality, Madhesh Province, Bara* by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of **10,000.00** till **25 May 2022 at 16:00 pm during office hours**.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their

6. Pre-bid meeting shall not be held.
7. Electronic bids must be submitted to the office **AadarshaKotwal Rural Municipality, Madhesh Province, Bara** by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before on **27May 2022, 12:00 pm**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **27 May 2022, 14:00 pm** at the office of **AadarshaKotwal Rural Municipality, Madhesh Province, Bara**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **50,00,000.00 (Rupees fifty hundred thousand only)**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. AadarshaKotwal Rural Municipality office, reserves the right to accept or reject any bids without assigning any reasons whatsoever, other terms and condition not covered here will be in accordance to PPA – 063 (addendum, 2077) and LBFAR – 064.
11. Other mandatory information shall be as per Public Procurement Act 2063 and Public Procurement Regulations 2064(Amended).
